FOR ACCREDITED LOUISIANA BRED FILLIES AND MARES THREE YEAR OLDS AND UPWARD. No nomination fee. \$350 to enter and \$350 to start. To be divided 60% to the winner, 20% to second, 11% to third, 6% to fourth, 3% to fifth. WEIGHTS: Three Year Olds...118 lbs. Older...123 lbs. Non winners of \$45,000 since December 30, 2011 allowed 3 lbs. Non winners of \$30,000 since December 30, 2011 allowed 5 lbs. Non winners of two races other than maiden claiming or starter since January 30, 2012 allowed 7 lbs.. This stake will be limited to twelve starters. Should this race not be divided and the entry number exceeds the starting gate capacity, preference will be given to horses having accumulated the highest lifetime earnings. Horses having common ties through ownership cannot start to the exclusion of a single interest. Failure to draw into the race will cancel entry fees. Trophy to the winning owner. (S)

U BELONG TO ME far back early, advanced entering the turn, responded entering the drive, split rivals upper stretch and was along in time. WARRIOR MAID stalked the early pace from the outside, inched closer entering the turn, responded when asked but could not reach the winner. WIRE ME BESSIE dueled from the inside early, battled through the turn, remained engaged through the drive but could not keep pace. IZZIE'S GOLD dueled from the inside early, remained engaged through the turn but tired in the drive. TINA LENA TOO forced the early pace but had nothing left. LAWSON'S LADY was no factor. LITTLE POLKA DOT showed little. CHERRY FOREVER was never close, pulled up entering the drive and was vanned off.
