FANCY DEALER unhurried, finished with a rush mid track and won going away. LITTLE LANEY hustled clear early, held a lengthy advantage, faltered late and lasted for second. MISS FLIT N FLOT devoid speed, advanced along the rail in the lane, eased out late and was gaining. A TAD EARLY raced back to the drive and closed late mid track. CHEAPERTOKEEPER within striking distance, lacked the needed rally. KRYSTINA'S DAY forwardly placed to mid stretch, faded. RUNAWAY CHU CHU could make little impact. DRINKSONME well back early, improved position. CHOCOLATEVILLE wide early, was no factor. SNOW MOUNTAIN dropped back. HEY LITTLE LADY retreated.
