NORTHERN ACRE veered out at the break, moved to the rail while out sprinted, advanced around the turn, swung out for the drive, closed resolutely and got up in the final strides. DESERT FROST chased FUZZY ANNIE down the backstretch, took over around the turn and then was caught at the wire. VELOURIOUS forwardly placed, made a run at DESERT FROST turning for home and then failed to sustain her bid. MISS ZAVALLA between foes while outrun, showed late interest. PEWS POND raced wide and could make little impact. MAGIC ECHO was always back. FUZZY ANNIE hustled clear early and faltered once headed.
