MISS BEAN WAH was setting a well rated pace on the backstretch, drew off in upper stretch and was kept to task in late stretch while setting a new track record. SKIPPING TOWN was allowed to settled then saved ground throughout, was inside in the stretch but was no match for the winner in late stretch while being second best. MUFFIN was allowed to settle then rallied on the far turn while three wide, made a bid in upper stretch but was outfinished for the place in the end. SUPERIOR STORM chased the early pace while racing two wide on the backstretch, made a bid on the far turn then faltered in the stretch drive. VICKIES IN TOWN was unhurried early then raced two wide on the far turn and was no threat in the stretch. E Z TIME was allowed to settle while racing on the inside on the far turn then failed to menace in the stretch. HISSE raced three wide on the backstretch then failed to menace in the stretch. CAT EYES trailed throughout.
