NO FLATTERY NEEDED stalked the early pace from the inside, steadily advanced entering the turn, remained inside for the drive, responded when asked, altered outside deep stretch and was just up the final strides. TROOPER OKIE dueled from the inside for the early lead, remained engaged through the turn, gained a clear margin at the eighth pole but was caught the final strides. BRAZILIONAIRE pressed the early pace from the inside, remained forward for the drive but could not keep pace. POWERED BY STEWIE chased the early pace from the outside, made a bid and finished well. SMASHIN THRU dueled from the outside and tired. WONDERLIC was no factor. BUSTED ACCOUNT chased the early pace and tired. STONE SKIPPER was no threat.
