AUBREY'S WALK was unhurried early while racing four wide on the turn, rallied in upper stretch and closed with a rush and was up in the final strides. BRIGHT KYLIE chased the pace while racing two wide into the turn, rallied in the middle of the turn and took command in upper stretch, lugged in sharply in mid stretch and drew off but was unable to withstand the late challenge and came up short. AUNT KAT KAT was settled then rallied three wide in upper stretch, made a bid in late stretch to finished strong. GOLD BANDIT raced four wide on the turn making a bid then raced evenly in the stretch drive. RUSTON KITTY set the early pace and drew off, was collared in upper stretch then shut off and forced to steadied in mid stretch then lacked a late bid. ANNIE MARIA was slow early on the started a run on the turn, moved out to be five wide for the stretch drive and found a best stride in late stretch. SOCIAL PRINCESS was settled then raced two wide on the turn and was no factor. MS JULIE PRIDE chased the early pace, was used up and stopped. A stewards inquiry was held concerning the stretch drive. Also a jockey claim of foul was lodged by the rider of RUSTON KITTY against the rider of BRIGHT KYLIE for interference in mid stretch. After reviewing the films, the stewards disqualified BRIGHT KYLIE from second and was placed fifth for interference in mid stretch.
