CONNOR'S DAY devoid speed, rallied outside before the drive, loomed inside the furlong grounds and prevailed. RICKY BOBBY forwardly placed along the inside, got steered out late for room and got up for second. VALID GROOMSTICK settled off the rail, split foes nearing the drive, gained the edge, then was outfinished. HURRICANE ISLAND forwardly placed, engaged ROPERRILEY midway down the backstretch, tried determinedly and gave way grudgingly. KING SETH devoid speed, rallied late mid track. TADL raced inside to no avail. CHARLIE'S CHOICE improved position. ROPERRILEY set the pace to the drive, then faltered. GOSHA moved out early, was unhurried down the backstretch, made a run around the second turn, then gave way. GAMBLEONTHESTORM showed little. BROWN GATOR forward for a half, retreated. PROMISING LIFE was always back.
