CAJUN MISS vied for the lead, gained the edge before a half and then weakened late. WOOTSIE DEAN was outrun. CASEY'S BID showed speed for a half and then tired. KYLE'S SQUAW showed early speed and then faded. AMBER'S COUNTY was always outrun. LIPLOCK stumbled at the start and trailed.
