FIONA MACINTOSH hustled clear early and lasted. LANCE'S LIL JADE forwardly placed, was getting to the winner. PARIS PRIDE saved ground and was along for the show. SHARP ARROW chased FIONA MACINTOSH to the drive and then weakened. MYSTIC JOURNEY bumped at the start by DUE A RUNNER, moved out to split foes before the turn, raced close up to mid stretch and then faded. MEMORIAL LADY hustled early, tired. LUBIE LUBIE DOO improved position. CRICKETS FRECKLE was outrun. DUE A RUNNER veered in at the break bumping MYSTIC JOURNEY, raced back early and was no factor. PARTY FOR HOURS showed little. JILL OF SLADES dropped back. GUIDRY'S LIPSTICK wide early, stopped before the turn and was eased.
