**Footnotes**

EASING BY chased the early pace from the inside, crept closer entering the turn, altered outside for the drive, responded and was just up the final strides. SCOOTA PETE forced the early pace from the outside, advanced entering the turn, responded but was outfinished. WILMA'S NUMBERONE well placed from the inside, altered outside entering the turn, dueled through the turn, drifted in slightly mid stretch then tired. GREY STREAM pressed the early pace from the outside, remained forward entering the turn, was steadied when in tight mid stretch then went evenly late. SLEEK EZEKE broke sharp from between foes to gain a clear early margin, dueled through the turn, remained forward entering the drive, was steadied, drifted out bothering rivals then tired, After a Stewards' Inquiry SLEEK EZEKE was disqualified for interference through the drive. RILEY'S VOO DOO was no factor. DEWBERRY well placed from the outside, crept closer entering the turn, was checked mid stretch then went evenly late. MAXIMUM RICHES had a steady fade.
