DA' GHOSTRUNNER chased the early pace from the inside, crept closer entering the turn, made a bid along the rail, split rivals mid stretch and was clear late. BECKSGOODFRIDAYBOY pressed the early pace from the outside, inched closer entering the turn, responded but could not match strides. STRONG DESIRE chased the early pace from the outside, made a bid entering the drive but could not keep pace. WILD TOKEN dueled from between foes for the early lead, drifted out entering the turn bothering rivals, continued to duel through the turn, drifted out slightly through the drive and tired late. After a Stewards' Inquiry into the running of the race, WILD TOKEN was disqualified for interference entering the turn. SLAMMIN BEAUTIFUL was steadied early when WILD TOKEN drifted out, steadied through the drive and was no factor. WHOA WHAM was no threat. DOUBLE HEARTED dueled from the inside for the early lead, stopped entering the drive and was vanned off. DR. SALOPEK was pulled up to avoid a fallen rival and was eased to the finish. COOL CAT

SHOES fell entering the turn over a fallen foe and walked off. LOTHARIO fell entering the turn over a fallen foe and walked off. ALONG THE COAST fell over a fallen rival and walked off. CHOUDRANT clipped heels, fell and walked off.
