GATOR DAWG dueled from the outside for the early lead, gained a clear margin up the backstretch, remained clear entering the second turn, widen the margin at the eighth pole and was well clear while kept to task. SOUTHERN FLING dueled from the inside for the early lead, chased the pace into the second turn, gained a forward position entering the drive but was no match while second best. M. V. P. HONOR forced the early pace from the outside, remained in a forward position entering the drive but could only gain the show. PLEASANT CHOICE forced the early pace inside but had nothing left. TAPPED TO THE MAX could only pass tired ones. CAT LAW was no factor. BID MY VALENTINE was no threat. CITY SAL had little interest. WHO DAT GHOST was finished after a half.
