SKY L broke sharp from the outside, gained a clear early margin, remained clear entering the turn, widen the effort at the eighth pole and was clear late while kept to task. ESTAR DE FUEGO well placed from the outside, inched closer entering the turn, responded but could not reach the winner. SPRINGVILLE forced the early pace from the inside, remained forward but could only hold position. FOXY APPEAL outrun early, advanced inside, altered outside for the drive and was gaining late. SPECIAL JEWEL RAE went evenly. PUCKTHEMAGICDRAGON chased the early pace outside but had nothing left for the drive. INTERN JURY was no factor. CANDLE DREAM was no threat. TRIPLE K PRINCESS chased the early pace outside and gave way. TINA'S DANCER forced the early pace from the inside, held a forward position for the drive, altered outside then was pulled up and walked off. EAST LOUISE was pulled up and vanned off.
