Footnotes

AFFIRMED TARGET saved ground while unhurried, made a steady middle move, eased out around HOUSTON DIAMOND around the turn, took over and then held on. MY PRINCESS RENE crossed to the inside going to the first turn, moved up around the second turn, swung out for the drive, then could not overtake the winner. DANCE MARY DANCE devoid speed, moved to the inside before the second turn, rallied for the drive, moved around HOUSTON DIAMOND inside the furlong grounds and got up for the show. MATTY'S PRINCESS unhurried, improved position. WINNING COMMENT forwardly placed

off the rail, came in a bit entering the second turn, then had no response while wide. POUR ME OUT forwardly placed off the rail, hung. HOUSTON DIAMOND vied three wide early, shook clear down the backstretch, was overtaken by AFFIRMED TARGET before the drive, then faltered. BRIANNA'S PRINCESS trailed for over a half, and was no real threat. MIGHTY TRUDY forwardly placed for a half, stopped. ENCHANTING BREEZE wide early, dropped back. HIGH HOPES ANITA vied between foes early, steadied approaching the second turn, stopped and was eased. FOLLOWING A STEWARDS INQUIRY, WINNING COMMENT WAS DISQUALIFIED FROM FIFTH AND PLACED FIFTH FOR CAUSING INTERFERENCE NEARING THE SECOND TURN.
