ATTAGIRL EMMA set the early pace from the inside on the turn, was in a long drive but could not last in the final strides. SWEET RUSTON was allowed to settled then rallied four wide in the stretch, was gaining ground and finished well. CAJUN CHU CHU was unhurried early then rallied two wide in the stretch and closed willingly in late stretch. MAIN STAGE was inside and saving ground then faltered in the stretch drive. MISS DEALBREAKER was inside on the turn and no factor. PRACTICE SQUAD was unhurried early and failed to menace. BOOGIE N AGAIN raced three wide on the turn then faltered in the stretch.
