MISS LAVADA never far back, lacked the needed rally. SARATOGA SIREN allowed to settle, was no real threat. RACE ME ROUND TOWN close up, advanced around the turn and then failed to sustain her bid. SIZZLIN SEMMIE was outrun. SUELAGRA was never dangerous. LADY MCGURIE was always back. OH RYLEE showed early speed and then retreated. WAY CON SUE sent to the lead, opened up around the turn and then stopped badly. I'M YOUR CAPTAIN showed early foot, stopped abruptly midway around the turn and was eased.
