BRUTE broke in, raced just off the leaders from the inside, steadied when ANGEL'S COURT pulled up nearing the sixteenth pole, moved inside that rival and held to the wire. RECORD TIME was bumped at the start, raced off the leaders from the inside and finished with a steady rally. INTINCTION chased the leaders from the outside, moved up to offer a bid nearing the five-sixteenths pole and finished willingly in the drive. BONNE WON raced off the leaders early, moved outside through the turn and finished evenly. MR. ROYAL showed no early speed, raced wide through the turn and finished with good late interest. DIABLO ACT was bumped at the start, raced off the leaders early, moved outside through the turn and finished evenly in the drive. JUS CADEAU was bumped at the start, lacked early speed and failed to threaten. CACTUS MAX raced off the leaders from the inside and gradually weakened. BIG HOUSE RICK was bumped at the start, raced just off the pacesetters from between foes and weakened in the drive. FIESTY GERALD was bumped from both sides at the break, raced just off the leaders from the outside and weakened after going a half. DIVIDED BY TWO raced off the pacesetters throughout and gradually weakened. ANGEL'S COURT broke in stride to take command at once, opened a clear lead before going a quarter, went wrong in

mid-stretch, was pulled up and vanned off.
