PERSONAL VELOCITY outrun early, circled rivals entering the second turn, responded to pressure to duel through the drive and was just up the final strides. DANDY'S LEGACY stalked the early pace from the inside, altered outside entering the second turn, dueled through the drive but was outfinished. JET RAIDER dueled from the inside early, gained a clear margin up the backstretch, dueled through the drive but was outfinished. TWILIGHT ROSS forced the early pace from the outside, remained forward but could not keep pace. MIZZEN'S WAKE was no factor. SEA THE SOLDIER dueled from the outside and tired. KARMA DISTRACTION dueled from between foes and tired.
