COLLIN TIME set a well handled pace from the start, drew off heading into the turn then was kept to task in the end. DRAKE'S LASER chased the early pace while two wide, made a bid on the turn but was no match for the winner in the end. CHARLIES CAMP was allowed to settled then rallied four wide on the turn, was four wide in the stretch but was no menace in late stretch. LEAH'S WARRIOR was allowed to settled then rallied four wide on the turn, was no factor in the stretch. ALASKAN CAUSEWAY was settled then rallied on the turn while three wide, made a bid then flattened out in the drive. MR JIMMYMAC was allowed to settled then failed to menace. FOREVER WAITING was allowed to settled then was no threat in the stretch. VILMAS BOUNTY chased the early pace while inside, was used up on the turn and faltered in the stretch drive. BRAZOS BREEZE was four wide on the turn and failed to menace. LUCKY LANDON was inside and saving ground then was shuffled back on the turn and stopped in the stretch. DEVIN'S BAD BOY was unhurried early and no factor. TEE GARCON was through early then stopped and was pulled up in mid stretch and walked off.
