COCO'S SHADOW allowed to settle early, tracked the pace up the backstretch, reached a striking position entering the second turn, responded when sat down for the drive and closed with a rush to be just in time. SOCIAL VICTORY well placed from the outside, advanced entering the second turn, made a bid to duel through the drive but was outfinished. SWEETTALKIN HOTTIE unhurried early from the inside, steadily advanced entering the second turn, responded and was gaining late. HONORARY GALLOP duelled from the inside early, remained in a battle up the backstretch, continued to be engaged through the second turn but had nothing left for the drive. MAID OF LIGHTENING stalked the early pace from the inside, crept closer entering the second turn, altered outside for the drive, gained a short advantage at the eighth pole but could not last. DAY GIRL duelled from the outside early, remained engaged up the backstretch, battled through the second turn then tired in the drive. MY COUSINS AND ME could only improve position. LUCKYLILGOLDDIGGER pressed the early pace and tired. LIVI'S VISION was no factor. ROSY DAY was never close. QUEEN OF PIZAZZ chased the early pace outside and tired.
