ETBAUER'S DEVIL chased the early pace from the outside, crept closer entering the turn, responded when asked and closed with a rush to be in time. RED RIVER MT. dueled from the outside early, remained engaged through the turn with RAHY BALBOA, put that one away entering the drive, gained a clear margin at the eighth pole but was caught the final stride. HEZA WALTZIN pressed the early pace from the outside, made a bid entering the turn and closed well late. KILN up close early from the inside, held a forward position for the drive but lacked the need late kick. MONTY LIGHTNING forced the early pace from the outside but had nothing left. SPARKS TO FLAME was no real factor. RAHY BALBOA dueled from the inside and tired in the drive. GRUBBS was no threat. FINEST FAREWELL was no menace. DELTA CHARGE had little interest. MAKIN' RAIN showed little. CHELSEA DIABLO forced the early pace from the outside and gave way.
