WILD BRE BRE broke sharp from the inside, gained a clear early margin, remained clear entering the turn, held a clear margin at the eighth pole then was all out to last. COSSINADE COVE stalked the early pace from the outside, inched closer entering the turn, responded and was getting to the winner. SARAH'S RIVER GIRL chased the early pace from the outside, crept closer entering the turn, responded but could not keep pace. TY'S CHOICE far back early, advanced outside, responded and finished well. TOPCATSTYLE went evenly. MISS RIKRAK could only pass tired ones. HEARTS AFIRE up close early, tired. ALLISON'S DREAM was no factor. LEGAL CHOICE had a steady fade. SKIP THE WALK had little interest. BLESSED EASTER showed little. FRENCH SECRET was never close.
