**Footnotes**

CALL TO SERVE showed speed, had the lead on the turn, took command in upper stretch and proved best. PORT WINE was in range, roused from between foes on the turn and from the three path through the stretch finished well. BAR IS OPEN was hustled early and forced the pace on the turn but from the four path at the top of the stretch had no kick while finishing on the rail. SHER'S EXPECTATION was in touch, hustled along from the three path on the turn and from the five path through the stretch had a good effort. DREAM CRUSADER was in mid pack and raced evenly from the three path on the turn but from the five path through the stretch had no impact. I'MGONNABESOMEBOY was unhurried early and had had a mild gain on the turn but lacked a serious bid. HOWWONDOFULITIS was off the pace, showed little and from the six path at the top of the stretch had a dull effort. SONORA SUNRISE had no speed and saved ground on the turn but failed to fire. SAMANTHA'S STAR was off the pace and trailed the field on the turn while never a threat.
