OFFICER'S DREAM showed speed, set the pace, took command from the four path at the top of the stretch and was much the best. HEREISTHERING was hustled early, forced the pace on the turn and was a factor from the five path at the top of the stretch but was second best. FOREVER BEAUTY was in mid pack and was roused from the inside on the turn but lacked a serious bid. CENT T MINT was off the pace and showed little while not a factor. CRAWFORD COUNTY showed no speed and saved ground on the turn in a dull effort. BELIEVE THE FOX was in range early but dropped back on the turn and was pulled up at the top of the stretch.
