**Footnotes**

TIME TRIAL was well back, moved up on the far turn and from the seven path through the stretch rallied in time. DON'TPUSHMEAROUND raced from mid field, was in tight on the far turn, had the lead from the four path in mid stretch but was outfinished. BORREGO ROAD was in touch, had a good position on the far turn and from the six path through the stretch finished well. YOU WOOD had no speed, was roused on the far turn and closed willingly through the stretch. BROMPTON ROAD stalked the early leaders and had the lead from the four path at the top of the stretch but gave way late. ELI was in mid pack and raced evenly from the inside on the far turn but had no impact. SARGEANT OF ARMS had speed and was a factor on the far turn but tired in mid stretch. REASON AND RHYME was off the pace and hustled from the three path on the far turn but from the six path through the stretch had no response. DEAFENING SILENCE was back early, showed little and from the six path at the top of the stretch was never a threat. FAR CANAL was away alertly and set the pace but duled on the far turn and had nothing left.
