BLUE RIDGE LINDA inside early, saved and closed on the turn, angled out then rallied strong to go clear in the final furlong. VOODOO LOUNGE well back in the early going, angled out after gaining into the stretch then finished fast. VAGUELY AMUSING had speed to show the way into the final furlong then faltered on the rail. KATA TJUTA came from off the pace to put in a mild late inside run. SPUNKY BOTTOMS stalked and bid 4-wide on the turn then evened out. ZIPPORAH in mid pack and in striking distance, had no bid while finishing inside. SPEED SUPREME chased the speed for a half from the outside then gave way. SWEET GLORY in mid field, failed to rally. DOWNUNDERTHUNDER (GB) was off the pace and showed little. PREY OF THE CAT outside and in touch early, backed away. COUNTRY MEADOW in mid field, lost ground to rivals and faded. RVEN HI trailed and was never close.
