Footnotes

PROUD OF MY ROOTS was unhurried early, had a mild gain on the turn and angled outside in mid stretch to get up in time. TEQUILAMOCKINGBIRD was hustled early, had a slim lead on the turn but drifted out in deep stretch, bumped outside rival and lost his whip. CRYSTA'S COURT showed speed, was a factor from the three path on the turn and vied through the stretch but was outfinished. DANCE TO THE MOON was up close and forced the pace on the turn but was bumped in deep stretch while all out. CARELESS WORD tracked the leaders from the outside and raced evenly on the turn but from the four path at the top of the stretch had no late kick. LUCKY MELISSA was well back and closed the gap on the turn but lacked a serious bid. RUE DE JEAN had no speed and showed little while never dangerous. A STEWARDS' INQUIRY AND A CLAIM OF FOUL BY THE RIDER ON DANCE TO THE MOON AGAINST TEQUILAMOCKINGBIRD FOR INTERFERENCE IN THE STRETCH RESULTED IN TEQUILAMOCKINGBIRD BEING DISQUALIFIED AND PLACED FOURTH.
