MOUNTAIN ECHO had no speed, moved up from the three path on the turn and from the five path through the stretch shook clear late. BOB N WEAVE stalked the leader, had the lead on the turn, vied through the stretch and fought gamely in defeat. POLITELYPRECOCIOUS was back early and moved up on the turn but from the four path through the stretch needed more. STARS BREW was up close and raced evenly from the inside on the turn but lacked a late response. HOPE'S PASS showed speed but chased on the turn and weakened late. SPIRIT'S WINE was in mid pack and saved ground on the turn but from the three path through the stretch failed to fire. HEART OF COLD was in touch and a factor from between foes on the turn but from the three path at the top of the stretch had no kick.
