NATURAL TALENT was in touch, raced evenly on the far turn and rallied inside through he stretch. MACHO FORCE stalked the leader, forced the pace on the far turn and had the lead from the five path at the top of the stretch but drifted in through the lane. MOVIE ROCK set the pace, was headed on the far turn and vied through the stretch but was outfinished. FOUND THE TREASURE was off the pace, saved ground on the far turn and from the five path at the top of the stretch gained gradually. LETAPROHAVEAGO was in range, roused on the far turn, raced from the four path at the top of the stretch and was steadied late. AWAKE BY NOON was well back, showed little and failed to fire. BULLET BOY showed no speed and was hustled on the far turn but from the four path at the top of the stretch had no impact. A CLAIM OF FOUL BY THE RIDER ON LETAPROHAVEAGO AND A STEWARDS' INQUIRY INTO THE STRETCH RUN RESULTED IN MACHO FORCE BEING DISQUALIFIED AND PLACED FIFTH.
