BANYAN COURT was off the pace, gained ground from the inside on the turn, was a factor through the stretch and drew off. PRINCE NICHOLAS was well back, had a mild gain from the inside on the turn and rallied through the stretch to get up for place. ROYAL EXPLOSIVE was in mid pack, moved up on the turn, three path at the top of the stretch in a good effort. MOLINARO COMPARO was up close, dueled on the turn and had a slim lead through the stretch but weakened. BRAVE SPIRIT was back early, hustled on the turn, four path at the top of the stretch but needed more. YEUNGZ BOY was well back, raced evenly on the turn and had a mild rally through the stretch. LONG PANTS rushed up early, dueled on the turn and gave way in the stretch. TIMELESS TOMAHAWK was in touch, hustled from the four path on the turn, six path at the top of the stretch and finished evenly. DREAM TREASURE was in range,

roused from the three path on the turn, five path at the top of the stretch and had no kick. SAN GOLD showed no speed and trailed on the turn but passed tired foes in the stretch. B SHARP was kept close, backed away on the turn, four path at the top of the stretch in a dull effort. ALEX DE CAT was away alertly, checked shortly after the break and was never a threat.
