**Footnotes**

ISLE OF TUNES in mid field, gained ground while 3-wide on the turn, bid in the drive, caught fire in the late stages and was up just in time to nail the leader at the wire. ACTION ATTRACTION had speed to force the early pace, led on the turn, opened a gap and looked a winner in the final sixteenth then was nailed at the wire by outside rival. PERSUE stayed close up throughout while 3-wide early, tracked on the turn then needed more in the stretch run but was good for the show. ROSE OF ROXTON stumbled after the break, moved inside to be a contender on the turn then lacked the needed finish. PALACE OF DREAMS just off the early pace, was between foes on the turn then lacked the needed finish. AMBER'S GLOW raced off the pace and off the rail and was not a factor. MEET IN MIAMI broke awkwardly, trailed then passed tired ones. LIGHT THE PATH had inside speed to last for a half then faded. DAY OF ATONEMENT broke smartly then backed away and trailed the field home.
