Footnotes

KARRMONIO dueled in the early going and again on the turn then cleared from the rail and just held off rivals at the wire. BLUEDIAMONDINK dueled outside of foe on the turn, gave way then came again in the five path and was game to the wire. BUTABINBUTABOOM made up ground and rallied will up the inside in the drive to finish between foes at the wire. PORTERS COURT in mid pack and inside, was in full flight in the final furlong only to miss at the wire while between rivals. CREAM had a mild inside rally in the drive but came up short. ASCOTS PROSPECT tracked the speed duo and was in the hunt on the turn then finished well off the rail while evening out. HIGHLAND HEAT was off the pace, finished wide and did not menace. DEVIL'S PLAYGROUND broke awkwardly, was off the pace and not a factor. CUSACK trailed then failed to fire. FREEZE PLAY in mid pack and in the game on the turn, failed to find a five path stretch bid. TISROC backed off after showing brief speed. SON OF COMPADRE was off a step slow and never close.
