SMOKIN ABBY was hustled early, took command on the turn and was kept to task through the stretch. WHAT SAY YOU was in range, had a mild gain on the turn and held well for place in deep stretch. SOUL SYMPHONY was off slow, closed the gap on the turn and from the three path at the top of the stretch finished well. JENNY'S MAGIC was in mid pack and had a good position on the turn but from the four path through the stretch finished evenly. GINGER BREEZE was away alertly and hustled along from the four path on the turn but from the six path through the stretch had no rally. DISTINCTIVE TASTE showed speed but dropped back into the turn and from the five path through the stretch had no impact. KASHAYA was in touch and raced evenly on the turn but flattened out through the stretch. A CLAIM OF FOUL BY THE RIDER ON WHAT SAY YOU AGAINST SMOKIN ABBY FOR ALLEGED INTERFERENCE AT THE START WAS NOT ALLOWED.
