Footnotes

PERSUE tracked the speed from off the rail, bid and took command turning for home then was kept to task in the drive. ISLE OF TUNES bid 3-wide on the turn and kept the rally going to close on the leader and finish willingly. FLEET DEED off the early pace, made up ground and was between foes for the drive then rallied in the 5-path. LADY ON TOP off the early pace, was between foes turning for home then put in a mild bid. REASON FOR JUSTICE in mid pack, closed and was between foes for on the stretch turn, bid then needed more. ICE PELLET bobbled at the break then bid wide turning for home but did not threaten. FRESH BELIEVER was well back and failed to launch a serious threat. PREJM had speed to lead early, held it into the turn then gave way and faded. SEA WAY LADY pressed the pace from the inside, tired on the turn and trailed the field home.
