**Footnotes**

PLACE NAME HERE was never far back, raced two then three wide on the turn, rallied four wide into the stretch, closed well to make a bid near the three-sixteenths pole, drifted in while inching clear near the sixteenth-pole and held off the fast closing TRULY JUDY at the wire. TRULY JUDY bumped with a rival at the start, raced well back in the field, went four then five wide on the turn, rallied into the final furlong and finished fast but just missed. MAGICFROMTHEGITGO was hustled from the start, set the pace under pressure, dueled inside of ALARMING MR. G while off the rail on the turn, battled into the final furlong and weakened while just able to get the show. ALARMING MR. G bumped lightly with a rival at the start, pressed the pace on the outside, dueled three wide on the turn, battled into the final furlong, altered course while weakening near the sixteenth-pole then was not urged in the final strides and just missed the show. SNOW BANDIT settled off the pace, was urged along while inside on the turn, came under the whip in upper stretch and

lacked the needed response. SHOW CHROME broke a bit slow, was urged along on the outside, advanced while five to six wide on the turn, came seven wide into the stretch and had nothing left. MISS SULU was urged along on the outside, raced four then five wide on the turn, came six wide into the stretch and capitulated. THAT SILVER bumped lightly with a rival at the start, raced in the middle of the field went three wide on the turn and failed to threaten. HOTTY TODDY REBEL lacked early speed, raced off the rail on the turn and showed little. FALSELY ACCUSED was ridden along towards the rear, raced two to three wide on the turn, moved to four wide outside the quarter-pole, came six wide into the stretch and failed to respond. RACHEL'S THUNDER showed no early speed while ridden along, raced near the inside on the turn and was outrun. ROCK N ROLL BRICK bumped with a rival at the start, chased the pace, raced three to four wide on the turn, came up empty at the top of the stretch and stopped. Following the race, the rider of ALARMING MR. G lodged an objection against PLACE NAME HERE for alleged interference in deep stretch. After the stewards' review, no change was made to the order of finish.
