MENA TIME close up, lacked the needed finish. COEUR D'ARC reserved off the rail, continued out to rally but failed to sustain her bid. DEPUTY DAMSEL devoid speed, showed late interest. GO HOOTS GO back early, rallied wide and improved position. TRIP TEASE forwardly placed too the drive, weakened. MAIARA settled off the rail early, got out a bit around the turn and was no real threat. CRAWFORD COUNTY out footed early, had no response. STEPSISTER JONES well back to before the drive, was not a factor. HIGH CLASS HONEY saved ground too no avail. HOME STREET stalked CLOUDBURST to the drive and then stopped.
