**Footnotes**

LUSTERDUST settled in the middle of the field, advanced two to three wide on the far turn, made a bid inside the quarter-pole, dueled with PERFECTLY CRAZY in the final furlong and gamely prevailed. PERFECTLY CRAZY was unruly in the gate, got his legs over the side railing, lagged at the rear of the field while on the inside, commenced a rally on the far turn, closed well into the stretch, steadied outside the three-sixteenths pole, came between rivals to make a bid near the eighth-pole, battled with LUSTERDUST in the final furlong and just missed. MEDIA CONTACT raced three wide on the first turn, settled in the front half of the field, chased inside on the far turn, made a rail bid near the five-sixteenths pole, battled into the final furlong and weakened while clear for the show. MALIBU RHYTHM raced four wide on the first turn, settled well off the pace, moved closer while urged along and four wide on the far turn, shifted six wide outside the quarter-pole and came up empty. CHARLIE MOON raced four wide on the first turn, followed the leader from second, chased three to four wide on the far turn, drifted five wide outside the quarter-pole and had nothing left. WICKED DREAMS was restless in the gate when PERFECTLY CRAZY came over into his stall, went three wide on the first turn, dropped well off the pace, was hard ridden on the far turn and failed to respond. COUNTRY LAKE raced off the rail on the first turn, set the pace, lost the lead near the quarter-pole and gave way.
