STAKES LeComte S. Grade 3 - Thoroughbred

FOR THREE YEAR OLDS. By subscription of \$100 each (Louisiana Derby early bird nominees automatically subscribed); \$400 to enter; \$500 additional to start. Supplemental nominations of \$2,000 will be accepted at time of entry which shall include all fees.

\$100,000 Guaranteed of which 60% to the winner; 20% to second; 11% to third; 6% to fourth and 3% to fifth. Weight: 122 lbs. Non-winners of \$36,000 allowed 2 lbs.; \$25,000, 4 lbs.; \$20,000, 6 lbs. (Maiden and claiming races not considered in estimating allowances). Starters to be named through the entry box by the usual time of closing. NOTE: This Stake will be limited to 14 starters should race not be split. Preference to horses according to highest lifetime earnings excluding restricted races at the time of passing entry box. Equibase, Inc. records will be considered official for determining money earned. Different owners have equal draw according to earnings. Second choice high earners of a same owner entry receive no consideration over a single entry.

Failure to draw into the race will cancel all fees. THE OWNER OF THE WINNER TO RECEIVE A TROPHY. Closed Saturday, December 27, 2008, with 6 nominations (plus 94 early bird nominations).

Footnotes

FRIESAN FIRE restrained behind the leaders early, eased out before the second turn, ranged up outside AU MOON entering the drive, took over in mid stretch and proved best while kept to the task. PATENA reserved from early on, moved up nearing the second turn, angled out turning for home and closed gamely. AU MOON vied inside CITIZEN around the first turn, got clear before a half, responded when collared by FRIESAN FIRE nearing the drive, was overtaken and weakened late. UNO MAS three wide around both turns, closed mildly. BIG PUSH moved in going to the first turn, maintained a forward position to the second turn, then had no response. INDYGO MOUNTAIN hit the side of the gate and bobbed at the break, crossed to the inside while unhurried, continued inside until before the drive, eased out and was not a factor. CITIZEN vied for the early lead and then faded along the rail. DYNAMIC FORCE crossed to the inside early, continued inside and was not a factor.
