Footnotes

TEN AND WIN was ridden along while off the pace, raced off the rail on the turn, rallied in upper stretch, closed well to get the lead before the sixteenth-pole and prevailed under good handling. RETALIATOR was ridden along while off the pace, went two then three wide on the turn, moved out in upper stretch, rallied on the outside, closed well to make a bid near the sixteenth-pole but missed. REQUEST A PUCK was ridden along while off the pace, raced inside early on the turn then came off the rail, rallied in upper stretch, split horses near the furlong marker and finished willingly for the show. CANOFSPOTS bumped with AMBERS WILDCAT at the start, was ridden along while off the pace, went three wide on the turn, rallied into a good striking position in upper

stretch but lacked the needed response. VALENTINE EDDIE went to the front, set the clear pace, was challenged while inside on the turn, dropped out approaching the quarter-pole, re-bid near the furlong marker and gave way. SOUTHOMO broke a bit slow, dropped well behind, came four wide into the stretch and failed to threaten. AMBERS WILDCAT broke in and bumped with a rival, was ridden along in the back half of the field, went three to four wide on the turn and failed to rally. RED WHITE AND GURU was ridden along near the back while a bit green, raced inside on the turn, steadied while well out of contention in upper stretch and was no factor. DIBBLE DABBLE brushed with an opponent at the start, chased the pace through the turn and tired. COMMANDER LEE chased the pace on the outside, made a bid while three wide on the turn, inched clear outside the quarter-pole, lost the lead in upper stretch and gave way. LT. NICK was ridden along in the front half of the field, raced inside on the turn and came up empty. MAGIC CANDY was urged along towards the back, saved ground on the turn and never reached contention. SNUGGLEBUG raced well back in the field and showed little.
