TRAINING ROOM brushed with a rival after the start, was urged along while off the pace, raced three then two wide on the turn, was asked for more in upper stretch, rallied into the final furlong and closed strongly to get up late. BELEND was well placed just off the pace, waited while off the rail on the turn, was blocked from the three-sixteenths pole to the eighth-pole, moved to the inside and rallied then closed fast late but missed. BLUEHARD moved up in the early going, pressed the leader on the outside, vied two to three wide on the turn, lost touch with FINEST CAT nearing the eighth-pole, continued on willingly in the final furlong and narrowly earned the show. FINEST CAT was urged along while just off the pace, raced three to four wide on the turn, made a bid near the five-sixteenths pole, inched clear into the final furlong but was overtaken and just missed the show. WHERE'S CAIN broke in and hit the gate, moved up midway down the backstretch, went two then three wide on the turn, came four wide into the stretch and finished willingly but missed the minor awards. NATAWAKI set the pace under pressure, vied inside on the turn, lost the lead at the top of the stretch, checked while in tight against the rail in upper stretch then gave way. DYNAMIC TIME was urged along on the outside, raced four wide on the turn, came five wide into the stretch and lacked the needed response. KAT'S COURT brushed with a rival after the start, was urged along while off the pace, raced inside on the turn and failed to rally. Following a stewards' inquiry, BELEND was disqualified from second and placed sixth for interference in upper stretch.
