GRIFTER forwardly placed off the rail, bid outside HIGH CASCADE entering the turn, gained the edge around the turn, shook clear before the drive, responded when collared and was game to the wire. G. W.'S DEPUTY allowed to settle, rallied outside around the turn, loomed a furlong out and then could not overtake the top one. NOON AFFAIR forwardly placed, faded late and lasted for third. JUSTALITTLEMAGIC raced inside until nearing the drive, moved out and lacked a serious finish. HIGH CASCADE held the early lead, was collared by the winner entering the turn, got out sprinted around the turn and then tired. RAPADASH (IRE) was outrun. SOUTH CHRISTIAN lunged and hit the gate at the start, then trailed.
