**Footnotes**

LONESOME STREET took the early lead, raced four then three wide on the first turn, relinquished the lead midway down the backstretch, tracked CROSS VILLAGE on the outside, went three wide on the far turn, made a bid passing the five-sixteenths pole, kicked clear when set down in upper stretch and proved much the best then was eased up in the final strides. CROSS VILLAGE was taken in hand early, raced three wide early on the first turn then dropped to the inside, moved up to take the lead midway down the backstretch, vied inside on the far turn, lost the lead inside the quarter-pole and proved no match for the winner while able to hold the place. GRIZZLED ROBERT was reserved off the pace, raced inside on the far turn and lacked the needed response while able to get the show. CABERNEIGH raced two to three wide on the first turn, lingered towards the rear, was urged along while off the rail on the far turn, came three wide into the stretch and also lacked the needed response. IN NIKE'S HONOR was taken in hand early, raced three wide on the first turn, was rated off the pace, came under a ride near the five-sixteenths pole and failed to rally. HARMONIZER was taken back early, raced two to three wide on the first turn, lagged at the rear, was ridden along while three wide on the far turn, came four wide into the stretch and failed to threaten. AU MOON was caught four wide on the first turn, settled in the middle of the field, went three wide on the far turn, was asked near the quarter-pole and failed to respond. (Rail at 20 Feet)
