PUCKAPPEAL hustled early, came three wide around the turn, got clear nearing mid stretch, drifted in and held on. BEACH VIBE ALIVE out footed early, moved to the rail after entering the turn, continued inside to rally and was outfinished. ZEALUNAR unhurried, rallied mid track and was gaining late. SOXIE'S GOLD TOUR clear early, responded when collared nearing the drive, was overtaken before mid stretch, then faded. SURE FIRE TEMPEST raced inside and could make little impact. K J R VICTORY TYME was outrun. HEALTHYWEALTHYWILD forwardly placed, bid outside SOXIE'S GOLD TOUR around the turn, then faded inside the final furlong. WYNN D'NIRO was no real threat. KIOWA'S QUEEN B saved ground to no avail. GO SASSY showed little. AFFAIRATTHEODEO was never dangerous. FESTY MOON was always back.
