CAMA'RONEY prompted the pace from early on, gained the lead before the furlong marker and was all out to hold on. SOCCORY saved ground early, rallied between foes nearing the drive and closed late mid track. CHOCOLATE FUDGE back early, angled out for the drive and showed late interest. RUTHLESS ONE settled early, bid five wide in upper stretch and lacked the needed kick. BAND LADY reserved from the rail, had no response when asked. CHANCEISALADY set a pressured pace and then faded along the rail. HEAVENLY DAYS veered in at the break, was straightened, raced close up, bid three wide approaching the drive and gave way. MARK OF ZENARO was always back. COURTYARD slammed at the start, was outrun. KARENZ raced wide. ENDYMION MAID veered out at the break, recovered and was not a factor.
