DEPUTIFORMER devoid speed, rallied wide and got up late. SALIC LAW trailed early, advanced wide down the backstretch, bid outside the leaders around the second turn, gained the edge, then could not hold on. SPIDER POWER (IRE) within striking distance, lacked the needed finish. WATZ HIS NAME set the pace off the rail, got headed nearing mid stretch, then weakened late. WESTMORELAND close up, bid outside WATZ HIS NAME around the second turn, then faded. COSMIC KRIS raced inside to no avail. CAPE SAN BLAS forwardly placed, had no response.. RUCKUS was outrun.
