Footnotes

FOREST COAST contested the pace on the outside, vied three wide on the turn, was set down in upper stretch, drifted out under left hand urging nearing the eighth-pole, dueled in the final furlong and gamely prevailed under strong urging. BURGIS contested the pace on the inside of FOREST COAST while off the inside, vied off the rail on the turn, fought determinedly in the final furlong but missed. COUNCIL OAK settled on the outside, chased five wide on the turn, was carried out while making a bid near the furlong marker and was outfinished while able to get the show. SALUTING STORMYE was urged along while off the pace, raced three then four wide on the turn, moved out nearing the furlong marker and finished well to just miss the show. DUKES ALLEY chased the pace, raced four wide on the turn, moved out a bit near the furlong marker and weakened. NIGHT VISION was urged along while just off the pace, dropped back while four then five wide on the turn and failed to respond. CURRAGH MON broke inward at the start, moved up then chased the pace, raced two then three wide on the turn and came up empty. SOUTHERN SAINT settled off the pace, came under some urging while inside on the turn and failed to rally. MAJHOOD settled at the back of the field, was urged along while off the rail on the turn and failed to threaten. Following the race, the rider of COUNCIL OAK claimed foul against the rider of FOREST COAST for interference near the eighth-pole. After the stewards' review, no change was made to the order of finish. (Rail at 0 Feet)
