FIREHOUSE RED settled while off the inside, was asked while four to five wide on the far turn, rallied to the lead in upper stretch and edged clear under good handling. RUSTICANA went five to six wide on the first turn, contested the pace while well out in the course, dropped in leaving the backstretch, vied outside on the far turn, came under a drive in upper stretch, battled into the final furlong and was outfinished while just able to hold the place. ANNACLONE lagged at the rear of the field, was roused while three then four wide on the far turn, came five wide into the stretch and finished with good energy to just miss the place. GLAMALERT settled off the pace, was asked near the five-sixteenths pole, came three wide into the stretch and lacked the needed response. SHERRY ANGEL went three then two wide on the first turn, was rated just off the pace while on the outside, went two to three wide on the far turn, was asked near the five-sixteenths pole, came under a drive in upper stretch and also lacked the needed response. AUDINGTON went three wide on the first turn, was reserved off the pace, raced three to four wide on the far turn, was asked near the five-sixteenths pole, moved out in the stretch and failed to rally. BURNING RAGE broke in at the start, settled on the inside, was asked near the five-sixteenths pole, came off the rail at the top of the stretch, chased into the final furlong then weakened. RAIN TOWN contested the pace, vied inside on the far turn, came under a drive in upper stretch and gave way. (Rail at 8 Feet)
