BETA CAPO inside to the drive, angled out to rally, closed determinedly and drove clear late. ANTRIM COUNTY settled off the rail, rallied three wide before the second turn, bid outside CLAUDIA'S FORUM, gained the edge, was headed a furlong out and then while no match for the winner was game for second. CLAUDIA'S FORUM set the pace from early on, got headed around the second turn, regained the lead and then weakened late. CAJUN PRIZE devoid speed, made a late gain. WILLIST within striking distance, had no response. MARVEL WOOD stalked CLAUDIA'S FORUM until nearing the second turn, stopped abruptly, was eased and vanned off.
