### Footnotes

CAT WHO DAT went five then four wide on the first turn, was rated on the outside, drew even with five furlongs to run, inched clear passing the half-mile pole, raced off the rail on the far turn, was set down in upper stretch, battled with A P ZAPPER into the final furlong, shook off that rival shortly thereafter and edged clear under urging then was eased up late. A P ZAPPER went four then three wide on the first turn, settled off the pace, went three wide on the far turn, was asked near the five-sixteenths pole, made a bid at the quarter-pole, battled with CAT WHO DAT into the final furlong then proved no match while clear for the place. DEJA VOODOO set the pace, dropped back near the half-mile pole, shifted four wide midway through the turn, drifted five wide into the stretch and was best of the rest. WHAT A SIGHT was reserved while off the rail, came under urging on the far turn and failed to respond. I KNOW WHEN TO RUN saved ground on the first turn, lagged at the rear of the field, went two to three wide on the far turn and was no factor. ONE BROADWAY QUEEN stalked the pace, went wrong on the far turn and was pulled up then vanned off.
