CHEYENNE BREEZE sprinted clear early, got collared by SOMETHINGDANGEROUS nearing mid stretch, proved best under strong handling. SOMETHINGDANGEROUS out sprinted early, ranged up three wide, bid outside CHEYENNE BREEZE a furlong out and then had no final kick. PIC'S LEGEND settled along the inside, moved out midway around the turn and then closed gamely. CYPRESS COVE moved to the rail early while trailing, continued inside for the drive then lacked a serious rally. SUNKOSI unhurried, moved up approaching the drive and then faded. HIGH CASCADE stalked CHEYENNE BREEZE for a half and then stopped. GILDMORE off last, hustled up outside before the turn and then stopped abruptly in upper stretch.
